3 (a) The objects to be pursued by the company on its incorporation are:

2. To undertake retail sales not in physical stores, stalls, or markets, including through e-commerce, door-to-door sales, tele-calling, exhibitions, mobile vans, social media platforms, and other digital or remote marketing methods.
3. To engage in the import, export, packaging, labeling, branding, and selling of all kinds of consumer and agri-based products in India and abroad.

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To enter into agreements, contracts, and partnerships with individuals, companies, government bodies, and other legal entities for the furtherance of business.

2. To acquire, establish, maintain, and operate marketing offices, warehouses, logistics facilities, and other business support infrastructure.
3. To apply for and obtain licenses, permits, registrations, and approvals necessary for carrying on the business.
4. To provide training, seminars, workshops, and other promotional activities related to the products and services of the company.
5. To advertise, promote and carry out branding activities through various media including electronic, digital, print, and outdoor means.

4 The liability of the member(s) is limited, and this liability is limited to the amount unpaid if any, on the shares held by them.

5 Every member of the company undertakes to contribute:

(i) to the assets of the company in the event of its being wound up while he is a member, or within one year after he ceases to be a member, for payment of the debts and liabilities of the company or of such debts and liabilities as may have been contracted before he ceases to be a member; and

(ii) to the costs, charges and expenses of winding up (and for the adjustment of the rights of the contributories among themselves), such amount as may be required, not exceeding * rupees.

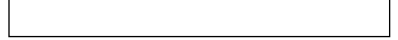
